- **Thursday, Sep. 28 at 11:59 p.m.** is your last chance to drop or change a [5-Week Session I](#) class. In [CyberBear](#), go to Student Services then Course Add/Change/Drop to initiate your request to collect necessary approvals. Approval is not guaranteed. No refunds. Fees may apply.

6-Week Session I (8/28 - 10/6)

- **Tuesday, Sep. 5 at 11:59 p.m.** is your last chance to drop or change a [6-Week Session I](#) class with refunds where applicable. In [CyberBear](#), go to Student Services, Registration, Register for Classes, then Drop/Delete and Submit.
- **Thursday, Oct. 5 at 11:59 p.m.** is your last chance to drop or change a [6-Week Session I](#) class. In [CyberBear](#), go to Student Services then Course Add/Change/Drop to initiate your request to collect necessary approvals. Approval is not guaranteed. No refunds. Fees may apply.

8-Week Session I (8/28 - 10/20)

- **Thursday, Oct. 19, at 11:59 p.m.** is your last chance to drop or change a [8-Week Session I](#) class. In [CyberBear](#), go to Student Services then Course Add/Change/Drop to initiate your request to collect necessary approvals. Approval is not guaranteed. No refunds. Fees may apply.

10-Week Session I (8/28 - 11/3)

- **Monday, Sep. 11 at 11:59 p.m.** is your last chance to drop a [10-Week Session I](#) class with refunds where applicable. In [CyberBear](#), go to Student Services, Registration, Register for Classes, then Drop/Delete and Submit.
- **Thursday, Nov. 2, at 11:59 p.m.** is your last chance to drop or change a [10-Week Session I](#). In [CyberBear](#), go to Student Services then Course Add/Change/Drop to initiate your request to collect necessary approvals. Approval is not guaranteed. No refunds. Fees may apply.
